ORTHOPAEDIC IN-TRAINING EXAMINATION (OITE) 2011

The Academy of Medicine, Singapore had taken over the administration of the OITE 2011 from the Chapter of Orthopaedic Surgeons.

STAFF REGISTRAR SCHEME (SRS)

With reference to the Ministry of Health's (MOH's) paper in early 2007 introducing the initiative of conducting a structured diploma programme with on-the-job training as previously proposed by the Academy of Medicine, Singapore (AMS) for foreign doctors whose specialist degrees are not recognised by the Singapore Accreditation Board and whose medical schools are not recognised by the Singapore Medical Council, the Chapter has rolled out its SRS Programme in April 2008. This is a three-year programme and the second intake currently has one (1) trainee.

The SRS Programme will ultimately be awarded a *Diploma in Orthopaedic Surgery* conferred jointly by AMS and the CSS. Dr Rajesh Vasant Asurlekar & Dr Ajay Purushothaman Nambiar have successfully completed the programme.
