MEMBERSHIP

The total membership as of 31 December 2012 under the Chapter of Orthopaedic Surgeons now stands at 73 Fellows comprising of 72 Local Fellows and 1 Overseas Fellow.

STAFF REGISTRAR SCHEME (SRS)

With reference to the Ministry of Health's (MOH's) paper in early 2007 introducing the initiative of conducting a structured diploma programme with on-the-job training as previously proposed by the Academy of Medicine, Singapore (AMS) for foreign doctors whose specialist degrees are not recognised by the Singapore Accreditation Board and whose medical schools are not recognised by the Singapore Medical Council, the Chapter has rolled out its SRS Programme in April 2008. This is a three-year programme and the fourth intake will be in year 2013.

The SRS Programme will ultimately be awarded a *Diploma in Orthopaedic Surgery* conferred jointly by AMS and the CSS.
