### Nominations for the 2018-2020 Council of the College of Psychiatrists

By stipulation of Regulation No. 43.3 under the By-Laws and Regulations of the Academy of Medicine, Singapore (AMS), an extract reads as follow:

"Apart from the first Vice-President, Secretary and Treasurer who shall hold office for a term of two (2) years, three Council members must step down for re-election at the second annual general meeting, and may be re-elected for a further term of two (2) years subject to a maximum consecutive term of eight (8) years and may seek re-election after a lapse of two (2) years thereafter.
