The College was set up on 6 August 2008 as a Company Limited by Guarantee. It was registered under the Charities Act on 27 June 2014 (Unique Entity Number (UEN): 200815442W). Its registered address is at 81 Kim Keat Road, NKF Centre, #11-00, Singapore 328836. Its internal auditor is Geetha A & Associates and its banker is UOB Bank.

OBJECTIVE

The College will improve and co-ordinate professional development with Specialty Societies and bodies, locally, regionally and internationally.

Through the representative(s) in the Chapters, Specialist Societies will be able to contribute to the development of clinical practice guidelines, recommendation of clinical indicators to the relevant authorities, drafting of consensus/position statements, certification and recertification of specialists, among others. The College may also provide secretariat support to societies.

The College will help to fulfil the professional development of dental specialist by conducting annual continuing professional education activities for dental specialists. In addition, the College plans to work towards the conduct of educational activities for non-dental professionals and the public, thus strengthening its "social role" for dental specialists.

The College will also collaborate with other Dental Colleges internationally and contribute to dental specialist organisations regionally. The College will aim to be proactive and take leading roles in the professional development and self-regulation of the dental fraternity.

FUNDING SOURCES

The College is financially supported by donations, income generated from conducting specialist accreditation examinations and other activities organised by the College.

The College held its 7th Annual General Meeting and Conferment Ceremony on 20 April 2015 at the Amara Hotel Singapore.

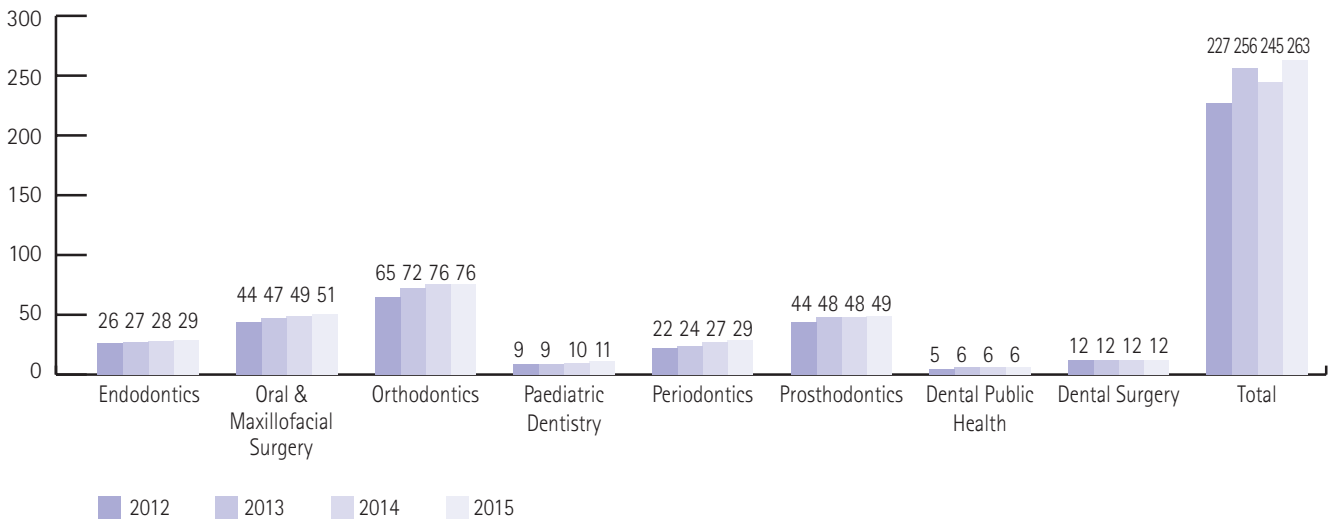
COUNCIL MEETINGS
