#### **SELF LEARNING MODULES**

All Colleges and Chapters under the Academy were assigned to assist transition from the current Continuing Medical Education (CME) to Maintenance of Certification (MOC) framework projected to be launched in year 2020. Under the proposed MOC framework, the Academy has been tasked by SMC CME coordinating committee to administer and operationalise a new Category 5 specialty-specific Self Learning Module (SLM) for all accredited specialists. The Chapter submitted 20 specialty-specific MCQs and would like to express its appreciation to the SLM section of the Chapter Board for its effort.
