# **MEMBERSHIP**

The total membership as of 31 December 2006 under the Chapter of Plastic Surgeons now stands at 29 Fellows comprises of 28 Local Fellows and 1 Overseas Fellows.

### DISTANCE LEARNING PROGRAMME

The Chapter Board has submitted the module on "Achieving a Zero Percent Re-operation Rate at 3 Years in a 50-Consecutive-Case Augmentation Mammaplasty Premarket Approval Study" to participate in the Distance Learning Programme adminstered by the Academy of Medicine, Singapore. Fellows who wish to access the Distance Learning Programme may do so by using their MCR number and password to login at the member secured login area at the Academy of Medicine website.

## **ACTION AGAINST DR ZUBIN MEDORA**

The Chapter of Plastic Surgeons has lodged a Statutory Declaration to the SMC to complain about the professional conduct of Dr Zubin Medora. The gist of the complaint relates to Dr Medora mis-representing himself as a specialist cosmetic surgeon in professional communications, the Internet and the general public, when he is neither a qualified specialist nor did he undergo any recognised plastic and cosmetic surgery training. To date, the SMC has yet to revert officially about the status of the Statutory Declaration.

# **AESTHETIC MEDICINE / SURGERY WORKGROUP CALLED BY MOH**

A workgroup to look into the practice and regulation of Aesthetic Medicine / Surgery was set up by the Ministry of Health this year. Dr Vincent Yeow, the Chapter Chairman is a member of this workgroup. The Chapter Board has walkthrough the survey form given by MOH pertaining to this subject and a compiled feedback represented from the Chapter of Plastic Surgeons was submitted to MOH.

#### **CME PROGRAMMES**

In the 1<sup>st</sup> Chapter Board Meeting on 27 July 2006, Dr Erik Ang was tasked to work with the Society of Plastic Surgeons, other Chapters if need be and the two teaching departments (Department of Plastic, Reconstructive and Aesthetic Surgery, SGH, and Division of Plastic Surgery, NUH) to establish an integrated CME programme for the Chapter Members.

# **ACTIVITY IN THE PIPELINE**

Table of Surgical Procedures (TOSP) Review called by Ministry of Health (MOH)

The Chapter understands that MOH will be calling for a TOSP review exercise at the beginning of year 2007 and the Chapter Board shall be actively reviewing the codes and submit a propose table to MOH in adherence to the timeline set by MOH.
