ACTIVITIES IN THE PIPELINE

Clinical Practice Guidelines

The Chapter Board is developing a set of best practice guidelines for the Otorhinolaryngology specialty. It will start with the following surgeries:

- 1. Tonsillectomy with/without Adenoidectomy
- Septoplasty
- 3. Inferior Turbinate Surgery

followed by other surgeries such as Tympanoplasty and Endoscopic Sinus Surgery.

These guidelines will be presented to the Chapter Members for discussion, confirmation and acceptance at the 1st Annual General Meeting of the Chapter to be held in May 2007 before being uploaded to the website of the College of Surgeons for reference.

Table of Surgical Procedures (TOSP) Review called by Ministry of Health (MOH)

The Chapter understands that MOH will be calling for a TOSP review exercise at the beginning of year 2007 and the Chapter Board shall be actively reviewing the codes and submit a propose table to MOH in adherence to the timeline set by MOH.
